CCSC- Three 13 week culinary training sessions each year where the students attend training under a barter system. In exchange for the culinary educational process, the students support the mission of the organization by helping other hunger based non-profit organizations housed in the same building as CCSC. The school assists students in finding employment. CCSC has a 76% job placement rate for its students. Students receive the Serv-Safe certification upon completion of the session.
