Community Culinary School of Charlotte, Inc (CCSC) provides training and job placement assistance for adults who face barriers in gaining successful long-term employment. Each year, CCSC conducts three 14-week training sessions, where students learn culinary skills necessary to obtain employment in the food service industry. Our curriculum also encompasses job-readiness skills and relapse-prevention services. Students attend CCSC on a barter system, preparing over 5,500 meals annually to community programs in low-income neighborhoods.

Encore Catering - An integral component of CCSC is its catering division. The purpose of Encore Catering is twofold: to give paid catering experience to our students and alumni, and to raise funds to help support the School. Encore provides an ideal training ground, while simultaneously generating revenue. 2015 reflects a full year in our Monroe Road location, after our move in mid-2014. Our current location encompasses a new revenue generating and training component for CCSC and its students. Our over-the-counter storefront Café further prepares our graduates for employment by offering front-of-the-house experience and customer service training. Like Encore Catering, created in 2001, our Café provides training and job opportunities to students and alumni while generating revenue for the school.
